Subject to conditions prescribed by the University of California, San Francisco Medical Center, sealed bids for a Lump Sum Contract are invited for the following Work:

**Moffitt/Long Hospital M15 Acute Care Nursing Unit - Demolition**

**DESCRIPTION OF WORK:**

Demolition of entire 15<sup>th</sup> Floor of Moffitt Hospital for future remodel and renovation. Work of the Project includes demolition of interior partitions, finishes, floors, ceilings, lighting, mechanical, electrical, and plumbing on the 15th floor of Moffitt. Selective structural verification and testing to be performed.

**THE ESTIMATED CONSTRUCTION COST OF THIS PROJECT IS \$1 Million to \$1.25 Million.**

**BIDDER QUALIFICATIONS:**

**Contractors:** To be allowed to submit a bid, Bidders (Contractors) and Bidder's Superintendent must have the minimum experience requirements, and Bidder must certify that they do not have certain health and safety violations as described below. To allow the University to evaluate Bidders, each Bidder must submit qualification documents consisting of an experience record and other required documents at the place and time stipulated in this Advertisement for Bids.. The experience record must be described in the Contractor's Statement of Experience form found in the Bidding Documents as Exhibit 13. To be allowed to submit a bid, the Bidder must demonstrate ALL of the following in the Contractor's Statement of Experience:

1. The prospective Bidder successfully completed one (1) project including all of the following:
  - a. Included demolition of mechanical, electrical, and plumbing.
  - b. Performed inside an operating Acute Care Inpatient Hospital (OSHPD I Facility) that includes Operating Rooms, Intensive Care Units and Patient Food Service/Kitchen. (Projects in a Skilled Nursing and Intermediate Care Facilities will not be considered for this requirement).
  - c. Immediately adjacent patient-care units remained in operation.
  - d. Performed in the State of California.
  - e. Cost at completion was \$250,000 or greater.
  - f. Completed within five (5) years of the date of this submittal or is at least 75% complete as of the date of this submittal.
  - g. Was managed and constructed under the business name submitting a bid.
2. Bidder's Superintendent experience on one (1) project as outlined in items 1 a-g above. Consideration will be given to prospective bidders for construction experience completed by employees for former employers, so long as that employee is listed as the proposed Superintendent for this project.
3. Contractor must further certify, by signing the Contractor's Statement of Experience (Exhibit 13), that neither they nor their firm have ever been cited by the Medical Center for health, safety, infection

control, or interim life safety violations while performing work in a Medical Center facility within the last 24 months of the bid opening date.

**PROCEDURES:**

Bidding Documents will be available to Bidders on **Tuesday, November 6, 2018 at 2pm.** Bidders are required to register as a supplier and complete the registration form at <https://app.buildingconnected.com/public/5549acff1c9ba80b00866b7b>. Bidders can obtain a complete set of the Bid Documents from the issuing office through the online bidding system, Building Connected.

**A mandatory Pre-Bid Conference and mandatory Pre-Bid Job Walk** will be conducted on **Thursday, November 15, 2018** beginning promptly at **9am**. Participants shall meet at **Moffitt Hospital, 15<sup>th</sup> Floor, Room M1538, San Francisco, CA, 94143**. Only bidders who participate in both the Conference and the Job Walk in their entirety will be allowed to bid on the Project as prime contractors. To be allowed to submit a bid, Bidder's must have the minimum experience set forth in the Contractor's Statement of Experience. Bidders must fill out the aforementioned Contractor's Statement of Experience (Exhibit 13) and submit it by **Thursday, November 29, 2018** at **2:00 PM and will only be received at** Office of Design and Construction, University of California, San Francisco, Medical Center, 3333 California Street, Suite 115, San Francisco, CA 94118. Phone: (415) 885-7257. The envelope shall be clearly labeled "Qualification Documents"

Bidders will be notified whether or not they are allowed to submit a bid for this project **within five (5) business days** of the due date of the Contractor's Statement of Experience (Exhibit 13).

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code sections 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$13 per hour as of 10/1/15, \$14 per hour as of 10/1/16, and \$15 per hour as of 10/1/17) and shall comply with all applicable federal, state and local working condition requirements.

The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:
