Subject to conditions prescribed by the University of California, San Francisco Medical Center, sealed bids for a Lump Sum Contract are invited for the following Work:

**1500 Owens Street Orthopedic Institute Operating Room Fit Out & Storage Project**

**DESCRIPTION OF WORK:**

Work includes conversion of an existing 2<sup>nd</sup> floor shelled space. The converted space will become Operating Room 5. The work includes converting open equipment space and lab space into Sterile Storage, and Clean Storage, respectively. Expansion of pre-sterile and installation of sterilizers is also included.

**THE ESTIMATED CONSTRUCTION COST OF THIS PROJECT IS \$1,000,000-\$1,250,000.**

**BIDDER QUALIFICATIONS:**

**Contractors:** To be allowed to submit a bid, Bidders (Contractors) and Bidder's Superintendent must have the minimum experience requirements, and Bidder must certify that they do not have certain health and safety violations as described below. To allow the University to evaluate Bidders, each Bidder must submit qualification documents consisting of an experience record and other required documents at the place and time stipulated in this Advertisement for Bids. The experience record must be described in the Contractor's Statement of Experience form found in the Bidding Documents as Exhibit 13. To be allowed to submit a bid, the Bidder must demonstrate ALL of the following in the Contractor's Statement of Experience:

1. The prospective Bidder successfully completed one (1) project that included all of the following:
  - a. A remodel or renovation of an operating room.
  - b. Immediately adjacent patient care areas remained in operation.
  - c. Performed in the State of California.
  - d. Construction cost at completion was \$500,000 or greater.
  - e. Completed within five (5) years of the date of this submittal or is at least 75% complete as of the time of this submittal.

Listed projects must have been managed and constructed under the business name submitting a bid.

2. Bidder's Superintendent experience on one (1) project as outlined in items 1 a-e above. Consideration will be given to prospective bidders for construction experience completed by employees for former employers, so long as that employee is listed as the proposed Superintendent for this project.
3. Contractor must further certify, by signing the Contractor's Statement of Experience (Exhibit 13), that neither they nor their firm have ever been cited by the Medical Center for health, safety, infection control, or interim life safety violations while performing work in a Medical Center facility within the last 24 months of the bid opening date.

**PROCEDURES:**

Bidding Documents will be available to Bidders on Tuesday, January 15, 2019 at 10:00 AM. Bidders are required to register as a supplier and complete the registration form at July 8, 2011

**A mandatory Pre-Bid Conference and mandatory Pre-Bid Job Walk** will be conducted on Wednesday, January 23, 2019 beginning promptly at 11:00 AM. Participants shall meet at 1500 Owens Street, Main Lobby, San Francisco, CA 94158. Only bidders who participate in both the Conference and the Job Walk in their entirety will be allowed to bid on the Project as prime contractors. To be allowed to submit a bid, Bidders must have the minimum experience set forth in the Contractor's Statement of Experience. Bidders must fill out the aforementioned Contractor's Statement of Experience (Exhibit 13) and submit it by **Tuesday, January 29, 2019** at **2:00 PM** and will only be received at the Office of Design and Construction, University of California, San Francisco, Medical Center, 3333 California Street, Suite 115, San Francisco, CA 94118. Phone: (415) 885-7257. The envelope shall be clearly labeled "Qualification Documents."

Bidders will be notified whether or not they are allowed to submit a bid for this project **within five (5) business days** of the due date of the Contractor's Statement of Experience (Exhibit 13).

Sealed Bids for Lump Sum will not be accepted after **2:00 PM, Thursday, February 14, 2019**.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code sections 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$13 per hour as of 10/1/15, \$14 per hour as of 10/1/16, and \$15 per hour as of 10/1/17) and shall comply with all applicable federal, state and local working condition requirements.

The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:
